1637 TO RECEIVE UPDATE ON KING STREET ZEBRA/YELLOW LINES

1637.1 Cllr Abel informed Cllrs that she had spoken to residents on King Street who were happy to proceed with further yellow lines. She had also taken photographs to send to East

Riding Council to avoid any further confusion on the exact location of the lines and would update Cllrs at the next meeting.

1637.2 Cllr Jump informed Cllrs that school waiting restrictions were due to be installed on King Street near to Hallgate Primary School.

1638 TO DISCUSS HULL ROAD ZEBRA CROSSING

The Clerk informed Cllrs that he had contacted both Humberside Police and East Riding Council requesting accident statistics at the Zebra Crossing but these had not, as yet, been received. He would circulate them to Cllrs when available.

1639 TO DISCUSS PROPOSED WAITING RESTRICTIONS- OAKDENE, NORTHGATE, BRICKNELL AVENUE, EPPLEWORTH ROD/GREEN LANE, AND HALLGATE

The Clerk had previously circulated new planning restrictions proposed by East Riding Council who has asked if the Parish Council had any objections/comments.

Cllrs were in favour of the restrictions.

1640 TO DISCUSS REQUEST FOR A FOOTPATH ON EPPLEWORTH ROAD FROM A164 FLYOVER TO BARKERS CORNER

The Clerk had circulated to Cllrs correspondence received from East Riding Councillor Richard Meredith which highlighted reasons given by East Riding Council why such a footpath would not be possible, the main ones being cost and lack of demand.

Cllrs felt that East Riding Council had not taken into account the increased usage of the area during Covid which, they believed, would continue. They felt that if cost was an issue the path could be a more informal one, a 'trod', and perhaps section 106 money could be used.

Resolved: Clerk to contact East Riding Council regarding a 'trod' on the hospital/south side of Eppleworth Road using Section 106 funds

1641 TO AGREE DATE FOR MAY PARISH COUNCIL MEETING

The Clerk informed Cllrs that, much to everyone's surprise, the Government had decided not to extend the regulations allowing Parish Council meetings to be held remotely beyond the 6th May and that though things could still change we would need to work on the basis that the meeting needed to take place prior to the May Planning Meeting on the 4th May if it was to be held remotely. If it was to be held face to face he recommend it took place on 27th May to give maximum time for preparations and vaccinations to occur.

Cllrs felt that it would be unfair to the Councillor elected on the 6th May bi-election to hold the meeting before this. They agreed physical meeting would need to be covid secure, have limited and pre-booked space for the public, and have hybrid capability.

Resolved: May meeting to take place on the 27th May in Covid secure venue
