1563 TO RECEIVE UPDATE ON CASTLE ROAD/WILLERBY LOW ROAD TRAFFIC ISLAND

1563.1 Cllr Jump advised Councillors she had been informed by the Highways department at ERYC that the traffic island had been installed to deter vehicles overtaking on Castle Road. Cllr Jump had also been informed by ERYC that the island should also be used as a midway point to cross the road and there are currently no plans to remove the island

1563.2 Councillors discussed their concerns of an imminent accident on Castle Road as they feel the island is not fit for purpose, should be removed and that a zebra crossing should be installed on Castle Road (a previous request by the Parish Council for a zebra crossing stall be installed was rejected by ERYC). Councillors agreed that Cllr Abel should write to Paul Tripp, ERYC head of highways, to voice their concerns and request the installation of a zebra crossing
