proposed bike shelter, due to be installed near to the Parkway shops, could no longer go ahead in that area but new locations were being investigated.

1686.3 Cllr Abel informed Cllrs that she had been approached by the Yorkshire Ambulance Service who wished to pay for a defibrillator to be installed near to the Parkway shops. Cllr Abel is currently in communication with several the shops to agree a suitable location.

Cllrs asked if the Clerk would highlight the location of existing defibrillators on the Parish Council noticeboards.
