1779.1 Deputy Clerk Nicola Pape read out the following email received from Cllr Abel:

"I am unable to attend the planning meeting as attending a prior appointment elsewhere and wondered if you would be kind enough to relay the information below for Item 5

I believe Councillor Jump mentioned speeding down Dunswell Lane during the recess of the Parish Council and I have also received correspondence regarding the same down Eppleworth Road and from this particular complaint a call was made to the Police by the complainant requesting a permanent speed camera down Eppleworth Road which the Police had stated they will look into but not as easy as it sounds

Contact was made to the Parish Council by Sasha from Humberside Police regarding a Speed Watch Scheme and from this I have spoken to her directly and was informed the scheme would involve volunteers who will be trained free of charge between the ages of 18-80 to operate a speed gun at chosen locations within Cottingham

I have arranged with Sasha a Police drop in at the Parish Council Office on Monday September 26th at 11am for approximately one hour for anyone to come along if they are interested in knowing more details about this. All the details will be put on the Parish Council Website and Facebook Page"

Cllrs were in agreement the arranged meeting on 26th September would be helpful
