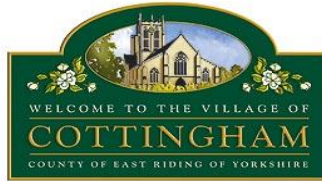

2123 TO RECEIVE AN UPDATE ON THE PROPOSED INSTALLATION OF SPEED INDICATOR DEVICES

2123.1 The Clerk referred to correspondence from ERYC outlining the reasons for delays in responding to the Parish council's applications and reported that a response was expected in the near future. Once this had been received an application could be made to the PCC for funding towards the devices. She also explained that an enquiry had been submitted to ERYC regarding whether Parish Councillors could be authorised to move the devices and what training would be required. A Councillor suggested that the Parish Council's insurers be contacted to clarify whether they would cover this activity if the appropriate permissions and training were in place.
