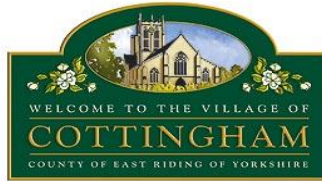

The Clerk had contacted East Riding of Yorkshire Council to enquire if this was feasible and been advised that, as bus shelters in the UK are considered to be considerably enclosed, it is unlawful to either smoke or vape in a bus shelter; this was an enforceable offence. East Riding Council will provide no-smoking signs to be placed within the bus shelter

2127.5 The Clerk reported that an update had been received from East Riding Council regarding the Cottingham Castle Hill car parking scheme; the current position being that the resident survey has now been completed and feedback reviewed and their engineering team is currently working to translate this feedback into initial design proposals - these draft plans will be used for a soft preliminary consultation with the aim of being launched during autumn 2025. Next steps: the soft consultation will help East Riding Council refine the proposals before entering the formal statutory consultation phase; beyond this point, timelines are less predictable and will depend on stakeholder responses. If the proposals are well received, the bulk of the legal and procedural work could be completed within the current financial year, if significant revisions are needed this may extend the timeline

2127.6 The Clerk reported that correspondence had been received from the Chair of Wold Newton Parish Council regarding Planning application NY/2025/0113/FUL – Construction of temporary wellsite for the exploration of gas, including drilling operation, well testing, the retention of the equipment and site restoration. Wold Newton Parish Council are encouraging Parish Councils and members of the public to view the proposals and submit their own comments to the Planning department at North Yorkshire Council. It was agreed this be discussed in further detail at the next Planning Committee meeting of Tuesday 7th October 2025

2129.1 The Clerk reported that a response from East Riding Council was expected in the near future regarding the proposed installation of speed indicator devices. Once this had been received an application could be made to the PCC for funding towards the devices. She also explained that an enquiry had been submitted to ERYC regarding whether Parish Councillors could be authorised to move the devices and what training would be required, a response was outstanding. The Clerk had contacted Zurich Insurance to confirm if the existing Parish Council insurance policy would permit Parish Councillors to move the devices; this would be permitted providing the Parish Council complete a Risk Assessment, correct PPE is worn if required and if working at height (on ladders) then there are more than 2 people working together with 2 holding the ladder while it is being used

2130.1 The Clerk referred to previous correspondence from East Riding Council. A Councillor requested that the office contact the East Riding Council Street Lighting department to seek reassurance that the current lighting meets the required minimum standards and to also propose that any existing single streetlights in this area be replaced with double headed lights.

The Clerk reported that both the police and the East Riding Council Safer Communities department had confirmed they had not received any Anti-Social behaviour reports for this area during 2024/2025 that would be of concern for the wider community
