TPO - PARK LANE, COTTINGHAM - 1987 (REF 189) W1 - Crown lift and reduce 1no. Scots Pine tree (T1) and 1no. Oak tree (T2) via removal of overhanging limbs (as illustrated) to provide clearance from large vehicles; Crown lift 1no. Oak tree (T3) by 1.5m to provide clearance for maintenance beneath; Crown lift 2no. Oak trees (T4 and T5) and 1no. Sycamore tree (T6) to 5.5m and remove basal regeneration to provide clearance from footpath and highway; Crown reduce 1no. Oak tree (T7) via removal of 1no. secondary limb to reduce risk of damage to telephone lines - Land and Trees North of 3 Ferens Gardens, Cottingham HU16 5SP

2139.1 The Clerk reported that a response from East Riding Council was expected in the near future regarding the proposed installation of speed indicator devices. Once this had been received an application could be made to the PCC for funding towards the devices. The Clerk and Cllr Casson had again contacted East Riding Council following the last Planning Committee meeting of 16th September seeking an update, neither had received a reply

2140 TO RECEIVE AN UPDATE ON REQUEST FOR LIGHTING ON SOUTHWOOD AVENUE

2140.1 The Clerk reported she had contacted the East Riding Council Street Lighting department to seek reassurance that the current lighting meets the required minimum standards and to also propose that any existing single streetlights in this area be replaced with double headed lights. A reply had been received stating that all lighting within the East Riding, with the exception of the occasional blackspot lighting owned by Parish Councils, conforms to British Standards. It had also been stated that regards to installing double heads, this will have little impact on the areas and the East Riding Council does not have funds to increase their asset burden in this way.

It was agreed that the resident who had expressed concerns regarding the lighting in this area be contacted by the office with an update, they will be advised that the Parish Council has investigated every avenue to try and assist, that East Riding Council have stated that the lighting conforms to British standards and that both the police and the East Riding Council Safer Communities department had confirmed they had not received any Anti-Social behaviour reports for this area during 2024/2025 that would be of concern for the wider community. A general letter drop to other residents in the area regarding the street lighting on Southwood Avenue will be undertaken by Councillors

Resolved: that the resident who had expressed concerns regarding the lighting in this area be contacted by the office with an update; Councillors will undertake a letter drop to residents of the Southwood Avenue area regarding the street lighting facilities
