2154 TO RECEIVE UPDATE ON THE PROPOSED INSTALLATION OF SPEED INDICATOR DEVICES

2154.1 The Clerk reported that a further response had been received from East Riding Council, it was noted that whilst Lamppost 10 on Northgate Lane is suitable for a SID, any proposed installation on an existing streetlight will be referred to East Riding Council Street Lighting team, who will assess the column's structural integrity and suitability for mounting a SID. There is no charge for this assessment, and it must be completed before approval and licensing can be issued. Regards powering SIDs and mounting requirements, the guidance confirms that SIDs should be battery or solar powered; they are not to be powered directly from the lamppost electrical supply. For a request to mount a SID on a streetlight column, the Street Lighting team must assess the column to ensure it can safely accommodate the weight of the device, solar panel, and/or battery. If any columns are unsuitable following this assessment, an alternative location or freestanding post will be required.

Installation and movement of SIDs must be carried out by professional contractors authorised to work on the public highway. All works must be notified through the Council's permit and noticing scheme. Whilst the Parish Council insurers will insure Parish Councillors to move the devices with training, the East Riding of Yorkshire Council policy requires the use of approved contractors for both installation and relocation. This is to ensure safety, compliance with highway regulations.

2154.2 Cllr Casson reported that the request for Parish Councils to install SIDs had been raised at a recent East Riding Council Full Council meeting, it was proposed the Parish Council forward a list of the proposed SID sites for Cottingham to Cllr Paul West at East Riding Council for further evaluation. Cllr Casson also reported that the SIDs would need to be moved every few months. Once a response had been received from Cllr West, the Parish Council could move to submitting an application to the PCC for grant funding towards the costs.

Resolved: that the Parish Council liaise with Cllr Paul West at East Riding Council regarding the installation of SIDs in Cottingham

2154.3 Cllr Graves reported that the SID on The Garth was not working, the SID at the bottom of Castle Road had been removed and whilst a SID had been installed near Langdale Crescent, this had not been switched on

2155 TO DISCUSS REQUEST FROM RESIDENT TO INSTALL YELLOW LINES ON KINGSWAY, COTTINGHAM

2155.1 The Clerk reported a resident had contacted the office requesting yellow lines and road repairs for Kingsway, Cottingham. The resident was concerned that driveways are being blocked and a number of vehicles are parking on the pavement, obstructing the view of motorists. Cllr Casson reported that East Riding Council has planned road repairs to be undertaken on Kingsway prior to April 2026. It was agreed that the Parish Office contact East Riding Council to request they consider installing yellow lines on Kingsway, with the Parish Council forwarding a response to the resident.

2156 TO DISCUSS UPDATE ON PROPOSED APPLICATION FROM DOGGER BANK WIND FARMS

2157 TO CONSIDER PROPOSAL BY ERYC TO INSTALL A NEW FOOTWAY FACILITY ALONG CASTLE ROAD, COTTINGHAM

2157.1 Councillors discussed a proposal from East Riding Council to install a new footway along Castle Road, Cottingham. The footway would formalise an existing pedestrian desire line and connect key routes including access to the bus stop sited at Willerby Low Road and the hospital. Cllr Casson reported he had met with a resident whose home falls within the proposed footway who had raised concerns regarding privacy issues. It was agreed the Parish Council supports the proposal to install the new footway.
