## 1608 TO DISCUSS KING STREET ZEBRA CROSSING

Cllr Abel informed the Committee that close to Aldi there was an approximate 3m gap between the yellow lines and zigzagged lines – cars are now parking in this space. The Councillors discussed that these lines should be joined up to prevent parking and agreed that Clerk Matthew Kay write to ERYC to request this work be carried out as soon as possible. An update will be given at the next meeting .

## 1609 TO DISCUSS WATER BUTTS

Councillors discussed offering grants to Cottingham residents – the grants to be used towards the purchase of water butts. It was agreed that a £300 budget be allocated for the 2021/2022 financial year (a maximum of £25 per grant request). Proof of receipt of purchase to be shown to the Parish Council for the grant funds to be allocated. Cllr Green was opposed to this – she felt in the current economic climate the funds could be better utilised elsewhere and also expressed that the water butts must be used for residential properties and not for allotments. Cllr Casson requested that the grant offer be advertised in the Cottingham Times and that residents also provide photos of their installed water butts once purchased
