1520 TO RECEIVE UPDATE ON KING STREET AND CASTLE ROAD

Cllr Abel reported that East Riding Council had been seen measuring up for a potential crossing point on King Street however residents had raised concerns regarding its locations. She had no further news regarding the bus stop on King Street or crossing on Castle Road.

Cllr Green reported that East Riding Council are currently considering a zebra crossing on Castle Road

1521 TO DISCUSS THWAITE STREET/NEW VILLAGE ROAD/HULL ROAD ROUNDABOUT

The Clerk reported that he had contacted ERYC raising the Councils safety concerns. They had responded that safety at the roundabout was still under consideration but that it was unlikely the cycle lane would be extended around the roundabout for safety reasons.

Cllrs discussed the need for clearer indication of the cycle lanes approaching the roundabout

Resolved: The Clerk to recontact ERYC to request that green tarmac and clear signage indicating cycle lanes be put on the approaches to the roundabout.

1522 TO DISCUSS TREES AT THE LAWNS SITE

The Clerk reported that he had contacted Pauline Labourne at East Riding Council to investigate if a TPO on the site was possible. She had replied that, unfortunately, large scale TPOs are no longer considered good practice but assured the Council that she was in regular contact with Hull University and currently no trees are under threat.

Cllrs also raised that the front area of the Lawns site is covered by the Neighbourhood Plan as a recognised open green space.

1523 TO DISCUSS COMMUNITY LED HOUSING

Cllr Casson informed Cllrs that Community Led Housing is also being looked at, particularly around the Needler Site, by the Neighbourhood Plan Working Party who are in the process of arranging meetings with East Riding Council and the developer.
