1550 TO RECEIVE UPDATE ON DISTRIBUTION OF NEIGHBOURHOOD PLAN SURVEY

1550.1 Cllr Casson updated Councillors on which streets had received the surveys and which still needed to be completed. Cllr Casson expressed his gratitude to those that had helped with the distribution

1550.2 The Councillors discussed that it was confusing that some streets were covered by two different wards and agreed that new Councillors should be assisted in gaining knowledge of which streets were covered by the four different wards. Cllr Jump will produce a map for all Councillors

Resolved: Cllr Jump to provide a ward map for each Councillor

1550.3 Cllr Jump informed the Committee that she would be emptying the boxes of completed surveys from the drop off points

1551 TO DISCUSS SOUTHERN BYPASS

1551.1 Cllr Jump provided the Councillors with an update from a meeting she had attended at Wolfreton School on 30th September 2019

1551.2 The Councillors discussed that Government funding would not be available to construct the bypass and discussed how many new houses would potentially be needed to be built to fund the project. Cllr Casson informed the Committee that the majority of the 960 new houses included in the current Neighbourhood Plan had already been built and these should generate an income from the developers of approximately £800,000 over 15 years

1551.3 The Councillors discussed a letter which had been sent to all Councillors from a local resident. It was agreed that Cllr Abel would contact the resident to discuss the content of the letter

Resolved: Cllr Abel to contact the resident to discuss the content of the letter
