Crown lift 8no. Maple trees (G1) and 3no. Oak trees (G1) to 4m and remove stubs for management purposes; Remove 25no. Elder and Sycamore trees (G1) as they are scrubby and self-set; Crown reduce 25no. Holly and Yew trees (G1) by 2-6m to promote scrubby growth; Fell 1no. Whitebeam tree (T2) as it is dying; Crown lift 1no. Oak tree (T6) to 4m due to low growth over path; Coppice 1no. Alder tree (T14) at 1m AGL due to dead top; Fell 1no. Beech tree (T17) as it is dying and potentially dangerous; Fell 1no. Sycamore tree (T18) as it is dead/dying; Fell 1no. Ash tree (T19) as it is in significant decline; Fell 1no. Ash tree (T20) due to poor form; Fell 1no. Cypress tree (G9) due to its inappropriate size and location; Crown lift 1no. group of mixed species trees (G9) by 2-4m AGL and crown reduce by 2-6m due to close proximity to walls, windows and gutters
